COMPOSITION COMMENTS

Contains Boric Acid 0.489% w/w; Copper Carbonate Hydroxide 2.19% w/w and Propiconazole 0.05% w/w.

3 HAZARDS IDENTIFICATION

Not regarded as a health or environmental hazard under current legislation.

4 FIRST-AID MEASURES

GENERAL INFORMATION

In all cases of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person.

INHALATION

5 FIRE-FIGHTING MEASURES

EXTINGUISHING MEDIA

This product is not flammable. Fire can be extinguished using: alcohol resistant foam, carbon dioxide (CO₂), powder, water spray/ mist. Do not use water jet.

SPECIAL FIRE FIGHTING PROCEDURES

As the product contains combustible organic components, fire will produce dense black smoke containing hazardous of combustion (see Section 10). Exposure to decomposition products may be hazardous to health. Appropriate self-contained breathing apparatus may be required. Cool closed containers exposed to fire with water spray. Do not allow run-off from fire fighting to enter drains or watercourses.

6 ACCIDENTAL RELEASE MEASURES

SPILL CLEAN UP METHODS

Exclude sources of ignition and ventilate the area. Exclude non-essential personnel. Avoid breathing vapours. Refer to protective measures listed in Section 7 and 8. Contain and collect spillage with non-combustible absorbent materials, e.g. sand, earth or vermiculite, and place in a suitable container for disposal in accordance with the waste regulations (see Section 13). Clean preferably with a detergent; avoid the use of solvents. If the product enters drains or sewers, immediately contact the local water company; in the case of contamination of streams, rivers or lakes, the relevant environment agency.

7 HANDLING AND STORAGE

USAGE PRECAUTIONS

Keep away from heat, sparks and open flame. Avoid skin and eye contact. Smoking, eating and drinking should be prohibited in areas of storage and use. Wear suitable protective clothing and gloves. Do not breathe spray. Otherwise wear respiratory protective equipment and eye protection (see HSE Guidance booklet HS (G) 53: "The Selection, Use and Maintenance of Respiratory Protective Equipment - A Practical Guide". STORAGE PRECAUTIONS

Observe the label precautions. Store between 5°C and 25°C. Keep in a cool, dry, well ventilated place, away from sources of heat, ignition and direct sunlight. No smoking. Keep containers tightly closed. Keep only in original container. Keep out of reach of children. Keep in a safe place.

ENGINEERING MEASURES

10 STABILITY AND REACTIVITY

STABILITY
