Product use

: Coatings: Demidekk Ultimate Opaque Coating is an opaque, water-borne wood stain for exterior use, based on the AMA (Alkyd Modified Acrylics) technology. The combination of top quality binders and high contents of pigments protects the wood against the destructive effect of the sunlight, and offers an excellent weather resistance.

First-aid measures

First-aid measures

General

: In all cases of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person. If unconscious, place in recovery position and seek medical advice.

Inhalation

Skin contact

Eye contact

Ingestion

Extinguishing media

7. Handling and storage

Handling

: Keep container tightly closed.

Avoid contact with skin and eyes. Avoid inhalation of vapour, spray or mist. Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed.

Put on appropriate personal protective equipment (see section 8). Never use pressure to empty. Container is not a pressure vessel.

Always keep in containers made from the same material as the original one.

When operators, whether spraying or not, have to work inside the spray booth, ventilation is unlikely to be sufficient to control particulates and solvent vapour in all cases. In such circumstances they should wear a compressed air-fed respirator during the spraying process and until such time as the particulates and solvent vapour concentration has fallen below the exposure limits.

Storage

: Store in accordance with local regulations. Store in a dry, cool and well-ventilated area. Keep away from: oxidising agents, strong alkalis, strong acids. No smoking. Prevent unauthorised access. Containers that have been opened must be carefully resealed and kept upright to prevent leakage.
