PROPERTIES

Drying time Under normal drying conditions touch dry 1-2 hours, recoatable after 4 hours. Allow for

adequate ventilation during the drying period.

PREPARATION

New surfaces All surfaces must be sound, clean, suitably dry and free from anything that will interfere with

the adhesion of the materials to be applied. Powdery, polished plaster or dense surfaces should be primed with Macpherson Universal Primer. Porous surfaces should be 'mist' coated

with Macpherson Contract Matt thinned with up to 40% clean water.

COATING SYSTEM Apply two coats as required

APPLICATION Stir well before use. Apply by brush or roller. For airless spray dilution may be required. For

further information contact the Customer Relations Team.

CLEANING Return surplus material to container. Wash with clean water immediately after use.
